

Following such instructions, on April 30, 2001 Quality Water filed its annual report and sent a check to the order of the Department of State, copy of which is attached to this letter, and which became cashable to the Department of State on May 24, 2001. However, since as of October 16, 2001 the company's status still remained inactive in the internet records, the company filed an application for reinstatement, copy of which is attached to this letter, but so far the company's status still remains inactive although no rejection for this application have been received.


Due to the above information and since the company complied with its filling and payment obligations I formally request hereby to return Quality Water International, Corp. to its active status and to waive any penalties therein related.
