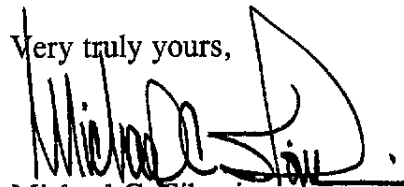

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be:

DunHill Bloodstock, Inc.

ARTICLE II

Principal Office

ARTICLE III

Purpose

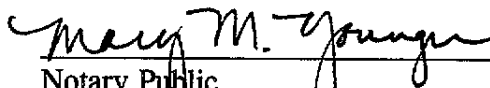

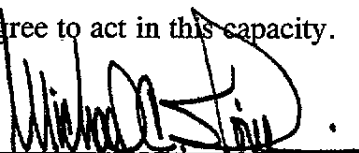
