ARTICLES OF INCORPORATION OF Florida IPSI, Inc.

The undersigned makes, subscribes and files these Articles for the purp forming a corporation for profit under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is Florida IPSI, Inc.

ARTICLE TWO

The principle place of business of the corporation will be in Winter Haven, Florida. The mailing address will be State Farm Insurance Companies, 7401 Cypress Gardens Blvd., Winter Haven, Florida, 33888.

ARTICLE THREE

The period of the corporation's duration is perpetual.

ARTICLE FOUR

The purposes for which the corporation is organized are:

- A. To lawfully facilitate the transacting of insurance by acting as an incorporated insurance agency for one or more insurance companies or carriers as permitted by law; and to contract with insurance companies and insurance agents and other persons for services related to the transaction of insurance in conformity with the Florida Insurance Code.
- B. To transact any or all lawful business for which corporations may be incorporated under the general laws of the State of Florida; and
- C. To do everything necessary, proper, advisable or convenient for the accomplishment and furtherance of such purposes.

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of voting common stock having a par value of one dollar (\$1.00) per share.

Cumulative voting of shares shall not be permitted. Further, the shareholders shall have no preemptive right to acquire additional, unissued, or treasury shares, or securities convertible to shares.
