
To whom it may concern:

Daly Enterprises was incorporated in November of 2000, only eight months ago. At the time of incorporation, I filled out all required forms and paid fees as asked by my registered agent, Speigel and Utrera, P.A.. I was told by my registered agent that the corporation would have to be renewed every year. I expected this to be a full year! Since I have never had a corporation before, and my attorney did not advise me that I needed to fill out a UBR form by May 1st, it was not done.

I *never received* a UBR form over the mail showing a deadline of May 1st, but I did receive one showing a deadline of September 12, 2001. I called your offices immediately questioning the fee. I was told I had missed an earlier deadline, but that if I write a letter explaining that it was not received and that the corporation had just been created, that it could possibly be corrected.

I am now very aware that an UBR form must be completed and sent every year before May 1, regardless of receipt of it in the mail, and/or incorporation date. Please take into account that I just gave birth two months ago and this corporation means a lot to me, I cannot afford to pay more. I've been a teacher for ten years and promise you that this was not irresponsibility in my part, but instead ignorance and lack of guidance. I appreciate all you can do for me. Thank you very much for your time and understanding. I have enclosed a check for \$155.00
