**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
POPULARCATEGORIES.COM, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The corporation was incorporated on October 12, 2000, under the name "POPULARCATEGORIES.COM, INC." (hereinafter referred to as the "Corporation").
2. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:  
  

**FIRST:** The corporate name of the corporation (hereinafter called the "corporation") is POPULARCATEGORIES.COM, INC.
3. The effective date of the amendment to the Articles of Incorporation of the Corporation set forth herein will be as of the date of filing of the Articles of Incorporation with the Secretary of State of Florida.
4. These Articles of Amendment to the Articles of Incorporation were duly adopted by written consent of the Sole Director of the Corporation, without shareholder action, and shareholder action was not required.
