Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned officer of TalentKeepers, Inc., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation, as adopted by the Board of Directors of the Corporation in an action by unanimous written consent and by the Shareholders of the Corporation in action approved by at least a majority of the holders of the outstanding voting stock of the Corporation, effective as of December 1, 2023 and December 11, 2023, respectively. ARTICLE FIRST: The name of the Corporation is TalentKeepers, Inc. and the Corporation's document number is: P00000106228.

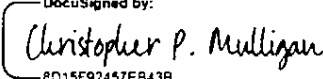
