

Pursuant to the provisions of Chapter 607 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation filed on October 13, 2000 according to the Certificate issued by the State, and assigned Charter Number P00000106367.

FIRST: The name of the corporation is currently CITRUS GREENS DEVELOPMENT CORPORATION, INC.

SECOND: The following Amendment to the Articles of Incorporation was adopted by the corporation, changing the name of the corporation:
