**ARTICLES OF INCORPORATION
OF
DANFORTH MOBILE HOME PARK, INC.**

The undersigned natural person, of legal age, acting as incorporator under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation shall be **DANFORTH MOBILE HOME PARK, INC.**

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

Purposes

The corporation may engage in any activity or business permitted under the laws of the United States of America and this State.

ARTICLE IV

Authorized Shares

The aggregate number of shares of stock which this Corporation shall have authority to issue shall be: (i) 100 shares of voting stock (each with a par value of \$1 per share) and (ii) 900 shares of non-voting common stock (each with a par value of \$1 per share). The holders of the voting common stock and nonvoting common stock shall have the same rights, privileges and powers, including, but not limited to the right to participate in dividends, except the holders of the nonvoting common stock shall have no voting rights and all voting rights shall be vested exclusively in the holders of the voting common stock.

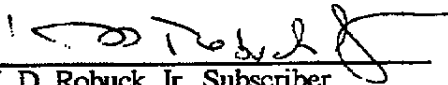
