OF

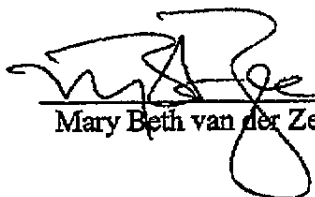
