### ARTICLE I Name of Corporation

The name of this corporation is HESCO REFUSE EQUIPMENT CORP.

### ARTICLE II Corporate Existence

This corporation shall have perpetual existence.

## ARTICLE III Purpose of Business

The purpose of this corporation is to engage in the transaction of any and all business permitted under the laws of the United States and of this state.

### ARTICLE IV Principal Place of Business

The address of the principal place of business of this corporation is 1380 W. 68<sup>th</sup> Street, Hialeah, FL 33014.

### ARTICLE V Registered Office

Any director of this corporation may vote upon any contract or other transaction between the corporation and any subsidiary or

controlled company without regard to the fact that he is also a director of such subsidiary or controlled company.

### ARTICLE XI Amendment

These Articles of Incorporation may be amended, changed, altered, or repealed only by majority vote of the outstanding common shares.


