ARTICLE I. - CORPORATE NAME

The name of this corporation is William A. Cobb & Associates, Inc.

ARTICLE II. - PURPOSE

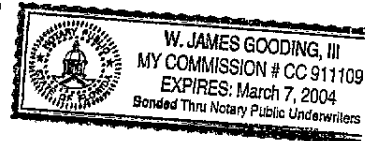
