ARTICLES OF INCORPORATION
OF
L.A.D. FAMILY HEALTHCARE SERVICES, INC.

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. NAME

The name of the corporation shall be:

L.A.D. FAMILY HEALTHCARE SERVICES, INC.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 1824 Vancouver Drive; Clearwater, Florida 33756, which shall also be the mailing address of the Corporation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$1.00 par value per share.

ARTICLE IV. INITIAL REGISTERED OFFICE
