CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF NEW TECH CONSTRUCTION ENGINEERING CONSULTANTS, INC.

Pursuant to the provisions of §607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST

Article X of the Articles of Incorporation is added as follows:

ARTICLE X PRINCIPAL OFFICERS OF THE CORPORATION

SECOND

Article XI of the Articles of Incorporation is added as follows:

ARTICLE XI

NUMBER. This Corporation shall have **one** (1) director initially. The number of directors may be increased or decreased from time to time as specified in the bylaws, but shall never be less than one (1) nor more than twenty-five (25). Each director shall serve an initial term to expire at the annual meeting next ensuing or until his or her successor is duly elected and qualified or until his or her earlier resignation, death or removal from office. Upon the expiration of the initial terms of office for each director, the directors shall be elected, except as provided in the bylaws, at the annual meeting of the shareholders, for a term of one (1) year and to serve until their successors are duly elected and qualified or until their earlier resignation, death or removal from office. The Board, by the vote of a majority of the full Board, may in any year between annual meetings of shareholders increase the membership of the Board by not more than two (2) members, and by like vote, appoint qualified persons to fill the vacancies created thereby which they shall serve.
