LOGIX 3, INC.

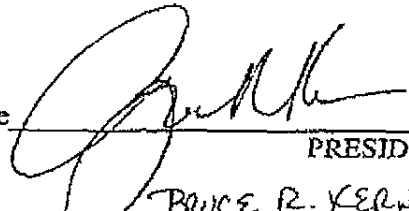
1. The name of this Corporation is Logix 3, Inc. (the "Corporation").
