ARTICLE I NAME

The name of this corporation is ALASKA LODGES, INC.

ARTICLE II PURPOSE

- This corporation is organized for the purpose of transacting any and/or all lawful business including, but not limited to, conducting the specific business of resorts.
- 2. To act on its own behalf in all legal or equitable proceedings or suits.
