# ARTICLES OF INCORPORATION OF

#### Allys of Florida, Inc.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

### <u>ARTICLE I - NAME</u>

The name of this corporation is Allys of Florida, Inc. and its principal office and mailing address is: 131 S. Barfield Drive, Marco Island, FL 34145.

#### **ARTICLE II - NATURE**

The nature of the business to be transacted by this corporation is:

retail clothing and specialty shop. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, cemeteries and playgrounds. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities or other evidences of indebtedness created by other corporation, and while owner of such stock, to exercise all rights, powers and privileges of ownership, including the right to vote such stock.
