#### ARTICLE I, NAME

The name of this corporation shall be ALLIANT TAX CREDIT IIB, INC.

#### ARTICLE II. PRINCIPAL OFFICE

The mailing address and principal place of business of the corporation is 340 Royal Poinciana Plaza, Suite 305, Palm Beach, FL 33480.

#### ARTICLE III. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of signing of these Articles of Incorporation. This corporation's duration shall be perpetual.

#### ARTICLE IV. PURPOSE
