## ARTICLES OF INCORPORATION OF ROBERT NEUWIRTH, M.D., P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a professional association under Chapter 621 of the Florida Statutes of the laws of the State of Florida.

### ARTICLE I. NAME

The name of the corporation shall be:




