The name of the corporation is: CROWN 21 INVESTMENTS, Inc.



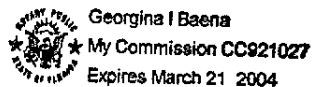


