ARTICLE I - NAME

The power to adopt, after, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.

A majority of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at the meeting of shareholders. If a quorum is present, the affirmative vote of a majority of the shares represented at the meeting and entitled to vote on the subject matter, shall be the act of the shareholders.

ARTICLE XIII - APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER

The approval of the shareholders of this Corporation to any plan of merger shall be required in every case, whether or not approval is required by law.

ARTICLE XIV - POWERS

- To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships or individuals or direct or E) Indirect obligations of the United States or of any other government, state, territory, governmental district

or municipality, or of any instrumentality thereof.

- To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue it's notes, bonds, and other obligations, and secure any of it's obligations F) by mortgage or pledge of all or any of it's property, franchises and income.
- To lend money for it's corporate purposes, invest and reinvest it's funds, and take and hold real and personal property as security for the payment of funds so loaned or invested. G)
- To conduct it's business, carry on it's operations, and have offices and exercise the powers granted by this Act H within or without this state.
- To elect or appoint officers and agents of the corporation and define their duties and fix their compensation. D

- To be a promoter, incorporator, partner, member, associate, or manager of the corporation, partnership, joint N) venture, trust, or other enterprise.
- To have and exercise all powers necessary or convenient to effect it's purposes. O)

ARTICLE XV - DIRECTOR QUORUM AND VOTING

A majority of the Directors shall constitute a quorum for a meeting of Directors. If a quorum is present, the affirmative vote of a majority of the directors present, or, if a director or directors have abstained from voting because of an interest in the matter to be voted upon, the affirmative vote of a majority of the directors present and voting shall be the act of the Board of Directors.

ARTICLE XVI - MEETING BY CONFERENCE TELEPHONE

Members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone as provided by law.
