# ARTICLES OF INCORPORATION OF

#### IRMA'S ENTERPRISE, INC.

The undersigned subscribes to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a Corporation for profit under the Laws of the State of Florida; and further do agree to the following condition of said Corporation:

#### ARTICLE I
