Dear Mr. Lang:

This letter is in reference to two certified articles mailed by your office to Masoud Fahimpour. A copy of the letters is attached.

The first letter, certified article Z198687420, was mailed by your office on November 21, 2000 to Mr. Fahimpour, Window Works, 1196-A Capital Circle NE, Tallahassee FL 32301. The letter was forwarded to Post Office Box 12174, Tallahassee FL 32317 in accordance with a change of address order filed by Mr. Fahimpour. Your office sent a second letter to Mr. Fahimpour on November 27, 2000 directly to Post Office Box 12174.

Mr. Fahimpour did not receive notification of attempted delivery for either certified due to an error in renting the post office box to him. When he rented the post office box, he was given the wrong box number for a post office box that was currently rented. He immediately filed a change of address order to have his mail forwarded from the street address to the post office box address. This order was processed by our carrier on November 21, 2000. When the error was discovered, Mr. Fahimpour and Window Works was assigned another post office box, 12415, and a change of address bypass order was entered on December 6, 2000.

Both of the letters you sent to Mr. Fahimpour were received during the interim period before the correction was made. The clerk who corrected the error did not think to check for accountable mail that was being held for the wrong box number.

On behalf of the Postal Service, please accept our apologies for any inconvenience experienced by you or Mr. Fahimpour as a result of this error. It is our desire to provide quality service to our customers at all times, and the service you received was not indicative of that goal.
