The undersigned, subscribers to these Articles of Incorporation is a natural person, competent to contract, and he does hereby present these Articles for the formation of a corporation under the Laws of the State of Florida.

**ARTICLE I**  
**NAME OF CORPORATION**

**ARTICLE II**  
**NATURE OF BUSINESS**

The general purposes for which the Corporation is organized are the following:

- A. International trade/import – export.
- B. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

**ARTICLE III**  
**CAPITAL STOCK**

The capital stock of this Corporation shall consist of One Hundred Shares (100) of

The Board of Directors, from time to time, shall determine whether or not and to what extent and at what time and place, and under what conditions and regulations, the accounts and books of the Corporation or any of them, shall be open to the inspection of the stockholders, and no stockholder shall have any right to inspect any account or document of the Corporation, except as conferred by a Statute, or authorized by the Board of Directors, or by resolution of the Stockholders.


