ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be R. CLINE & AFFILIATES, INC., a Florida Corporation. The principal office of the corporation is 5339 Chippendale Circle, East, Fort Myers, Florida 33919; the mailing address of the corporation is 5339 Chippendale Circle, East, Fort Myers, Florida 33919.

ARTICLE II - TERM OF EXISTENCE

This corporation is to have perpetual existence.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation shall be as follows:
