ARTICLE VI. RESIDENT AGENT/REGISTERED OFFICE.

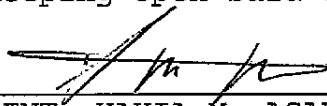

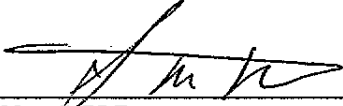
ARTICLE X. EFFECTIVE DATE.

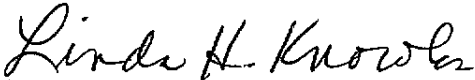

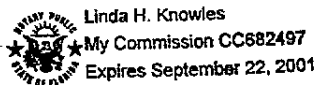
