ARTICLE 3. The principal place of business and mailing address of this corporation shall be 111 N. Orange Avenue, Suite 915, Orlando, FL 32801.


ARTICLE 4. The corporation is authorized to have outstanding, at any one time, 1000 shares of stock at a par value of \$0.01 per share.


