## ARTICLES OF INCORPORATION SPENCER BURNS, INC.

I, the undersigned, being of full age, for the purpose of forming a corporation under and pursuant to the provisions of Chapter 607 and/or Chapter 621, F.S. (Profit) of the Florida Statutes and laws amendatory thereof and supplementary thereto, do hereby form a body corporate and adopt the following Articles of Incorporation:

#### ARTICLE I

The name of this Corporation shall be Spencer Burns, Inc.

#### ARTICLE II
