
Gentlemen:

We are writing on behalf of the officers of Bunkley Transportation, Inc. who are delinquent in the payment of their 2002 Uniform Business Report which was due May 1, 2002. We understand that the payment was not paid timely but we believe the circumstances that led to late payment, warrant further consideration for the waiver of the delinquency penalty in this case.

Bunkley Transportation is a small business corporation that consists of one officer and stockholder, Zachary Bunkley. This is a startup business that Mr. Bunkley is trying get off the ground. His primary occupation is an air traffic controller in the Tampa area. Above and beyond the stress involved in being an air traffic controller, after the terrorists attacks of September 11, 2001, Mr. Bunkley's occupation has been extremely stressful due to the added security measures necessary since the attacks. Unfortunately, he had no time to devote to the fledgling corporation and the due date for the filing of the 2002 Uniform Business Report went by unnoticed.

We feel that in this case the state should accept the \$150.00 filing fee. Mr. Bunkley should be acknowledged and praised for his devotion to his duties as an air traffic controller, not penalized for failing to remember to file an annual report during the aftermath of the terrorists attacks. Also a \$400 penalty would be an extreme hardship on the finances of the corporation.
