In compliance with Chapter 607 and/or Chapter 621, F.S.(Profit), the undersigned incorporator hereby adopts the following Articles of Incorporation:

**ARTICLE I NAME**

The name of the corporation shall be: Meigs Alden, CRNA, Inc. (hereinafter sometimes referred to as the "Corporation").

**ARTICLE II PRINCIPAL OFFICE**

The address of the principal place of business of the Corporation shall be 4363 Pasadena Circle, Sarasota, Florida 34233, and the mailing address of the Corporation shall be 4411 Bee Ridge Road, #126, Sarasota, Florida 34233.

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:
