ARTICLE I

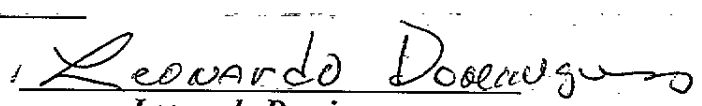
