**ARTICLES OF INCORPORATION  
TALLAHASSEE TRUCK & AUTO ACCESSORIES, INC.**

**I**

The Name of the corporation shall be **TALLAHASSEE TRUCK & AUTO ACCESSORIES, INC.**, whose principal office shall be located at 2168 W. Tennessee Street, Tallahassee, Florida 32304.
