The above referenced taxpayers have asked us to respond on their behalf concerning the late filing of their 2002 Uniform Business Report.

The 2001 UBR was the first report required to be filed by the taxpayers. Their attorney processed the filing of that form.

The ultimate shareholders of the taxpayers are Guatemalan residents and spend little time in the United States. Their attorney did not advise them of the annual requirement to file this form, nor did he suggest that they change the corporate mailing address to his office or ours, as their certified public accountants, so as to insure timely filing of the UBR on an annual basis.

The ultimate shareholders arrived from Guatemala last week to discover the second notice in their mail. To the best of their knowledge, they did not receive the first notice.
