TRUMAN J. COSTELLO, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for TRAINING JUSTICE ADMINISTRATION (TJA) & TRAINING RESOURCE GROUP, INC.

ARTICLE I  
(Name)

The name of the corporation shall be: TRAINING JUSTICE ADMINISTRATION (TJA) & TRAINING RESOURCE GROUP, INC.

The period of its duration is perpetual.






