Pursuant to the Florida Business Corporation Act, Article 1 of the Articles of Incorporation of **BETHANY TRACE ESTATES, INC.**, a Florida corporation, hereinafter referred to as the "Corporation", is amended to read as follows:

FIRST. The date of filing the Articles of Incorporation was November 20, 2000 (Document No. P00000107930).

SECOND. The following amendment to the Articles of Incorporation was adopted by the Corporation:

A. Article Number 1 of the Articles of Incorporation of the Corporation is hereby amended as follows:

**ARTICLE I Name**

The name of the Corporation is **WATERMEN-PINNACLE, INC.**

THIRD. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.

The foregoing Amendment to the Articles of Incorporation of the Corporation was proposed and unanimously approved by all of the shareholders and all of the directors of the Corporation by Joint Written Consent effective as of June 10, 2005.


