ARTICLE ONE

THE NAME OF THE CORPORATION IS PLANT CITY YELLOW CAB INC.

ARTICLE TWO

THE PERIOD, TERM AND DURATION IS **PERPETUAL**.

ARTICLE THREE

THIS BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS' BUSINESS AS A FULL SERVICE CAB COMPANY, WHEREIN, WE WILL SPECIALIZE IN THE TRANSPORTING OF PASSENGERS FOR HIRE AND PROVIDE ALL OTHER RELATED SERVICES AS PROVIDED FOR BY STATUE. 
ARTICLE EIGHT
