ARTICLES OF INCORPORATION OF DRAGON WOK, INC.

The undersigned subscriber to these Articles of Incorporation of DRAGON WOK, ENC., natural person competent to contract, hereby forms a corporation for p ofit under the laws of the State of

ARTICLE I - NAME

The name of this Corporation is DRAGON WOK, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

Section 3.01. Purposes. The purposes for which this Corporation is organized are as follows:

- a. To engage in the transaction of any and all business permitted under the laws of the State of Florida and of the United States.

Section 3.03. Conducting Business in Other Jurisdictions.
