

ARTICLES OF INCORPORATION
OF

I, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I -- NAME D.m

The name of this corporation shall be WEST COAST HOST INC.

ARTICLE II -- DURATION D.m

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III -- PURPOSE D.m

The general nature of the business to be transacted under this corporation shall be to engage in any activity or business permitted under the laws of the United States and the state of Florida. The specific nature of this business shall be to conduct Internet hosting services and web page design.

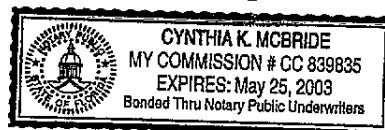
