ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of COAST 2 COAST VACATION HOMES, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I


