
ARTICLE IX - Indemnification

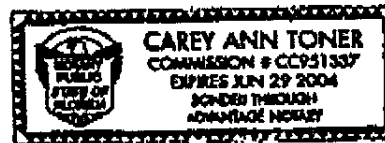
