

## ARTICLES OF INCORPORATION

ARTICLE 1. NAME: The name of the Corporation is Towns Industries, Inc.

ARTICLE 2. DURATION: The duration of the corporation shall be perpetual.

This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares preempted within sixty (60) days after the receipt of written notice—from the corporation stating the price, terms and conditions of the issue of shares and inviting the Shareholder to exercise this preemptive right. This

right may also be waived by a written waiver signed by the Shareholder.

ARTICLE 12. AMENDMENT OF ARTICLES: The corporation reserves the right to amend, alter, change, or repeal any provision or provisions contained in these Articles of Incorporation, or any amendment thereto, in accordance with the laws of the State of Florida as amended from time to time.
