#### ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation hereby form a corporation under the Florida Business Corporation Act.

#### ARTICLE I

The name of the corporation is: Chuck and Ellie, Inc.

# ARTICLE II Duration

The duration of the corporation is perpetual.

# ARTICLE III General Purpose

The general purposes for which the corporation is organized are:


