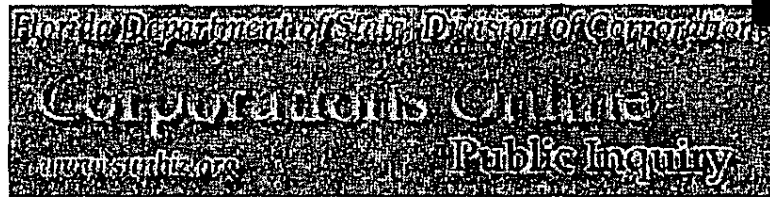


This is to let you that we were astonished to receive the UBR, which says file now the fees is \$550 and later \$750. We have never received a first notice for you requesting any payment.
