ARTICLES OF INCORPORATION

OF

Southern Lady Holdings, Inc.

ARTICLE I - NAME

The name of this Corporation is Southern Lady Holdings, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of the filing of these articles.

ARTICLE III - PURPOSE


ARTICLE IX - INDEMNIFICATION
