ARTICLE I. CORPORATE NAME

The name of this corporation is DREAM HOMES CONSTRUCTION, INC.

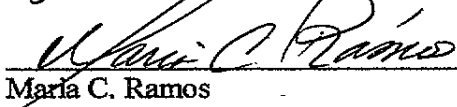
