I, the undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

First

The name of the incorporation shall be MACOFORT TRADING USA, INC.

Second

The period of its duration shall be a perpetual.

Third

The purpose of this corporation is to export goods and services, and/or any legal activities allowed by the State of Florida.

Fourth

The number of Shares of Stock that this corporation is authorized to have outstanding at any one time is 1,000 shares.

Fifth

Cumulative voting of shares of stock is authorized.





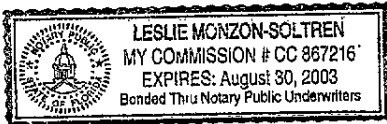
