CAROL LEONARD REALTY, INC.**

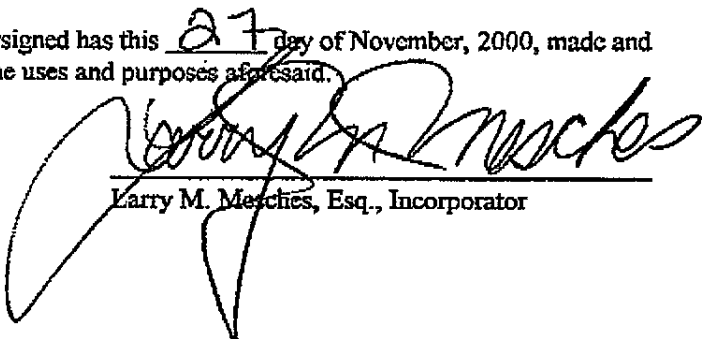
