ARTICLE I  
Name

The name of this corporation is PENINSULA SYSTEMS SERVICES, INC.

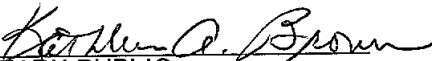

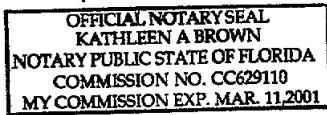
