THE UNDERSIGNED, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

ARTICLE IV

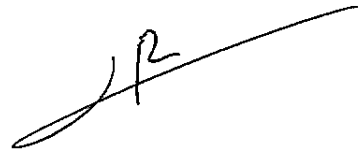
The Corporation is authorized to issue 100 shares at \$ 1.00 par value common stock.

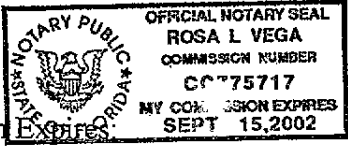

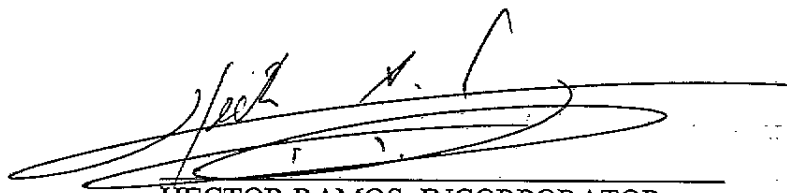
