The undersigned, JORGE DE LEON, does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of this corporation shall be FLORIDA J.D.L. CORP.

**ARTICLE II. NATURE OF BUSINESS**


