The undersigned, for the purpose of forming a corporation under the Florida Business Corporation

Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be QUINCY CARS AND TRUCKS, INC. The principal office or the mailing address of the Corporation is 739 South Roberts Street, Quincy, Florida 32351.

### **ARTICLE II - DURATION**

The duration of the Corporation is perpetual.

#### **ARTICLE III - PURPOSE**

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
